ELECTRONIC SUSPECTED CHILD ABUSE REPORT SYSTEM (E-SCARS)
2013 STATISTICS

In 2009, the District Attorney's Office, the Sheriff's Department and the Department of Children and Family Services (DCFS) jointly launched the Electronic Suspected Child Abuse Report System (E-SCARS). Every municipal police agency in Los Angeles County is participating in this innovative information-sharing system designed to protect our community's most vulnerable victims – children. Since its inception, more than 260,000 reports of child abuse have been entered into E-SCARS. Many law enforcement agencies have embraced E-SCARS, as well as their role in cross-reporting allegations of suspected child abuse to DCFS, and in responding to reports received.

As part of the District Attorney's Office statutory obligation to audit cross-reporting compliance, our office has compiled the enclosed comparative statistics for your review. These figures represent suspected child abuse reports received by law enforcement from DCFS and reports generated by law enforcement. The figures also illustrate the actions taken on suspected child abuse reports.

This letter contains data that you may find informative in evaluating on how your agency is meeting their departmental goals. We are providing you with specific statistics relevant to your agency and the average for all agencies in hopes that you may evaluate your department's performance as well as identify any specific areas in which improvement might be sought. Thank you for your continued support of this critical public safety program.
