

**SB 81 LOCAL YOUTHFUL OFFENDER REHABILITATIVE FACILITIES
CONSTRUCTION FINANCING PROGRAM
CORRECTIONS STANDARDS AUTHORITY
PROJECT STATUS UPDATE
Updated February 24, 2014**

On August 24, 2007, the Local Youthful Offender Rehabilitative Facility Construction Funding Program became law (as authorized by certain provisions of Senate Bill 81, Chapter 175, Statutes of 2007). The purpose of this financing program is to support the rehabilitation of youthful offenders at the local level. As such, pursuant to the legislative intent of SB 81, rehabilitation must be a core component of the operational philosophy of the facility subject to construction, expansion or renovation. In order to receive state financing for a local youthful offender rehabilitative facility project, each participating county must provide a portion of the project costs in matching funds. Each of the 14 below listed counties currently has a conditional award through the Corrections Standards Authority for state financing for local juvenile facility construction.

PROJECTS ACTIVE IN THE STATE PUBLIC WORKS BOARD PROCESS

Outlined below are the active local youthful offender rehabilitative facility projects that are established in the State Public Works Board approval and oversight process for capital outlay projects.

Stanislaus

This project resulted in the construction of a 60-bed youth treatment facility and related ancillary space in Modesto. Of the approximately \$23 million in project costs, the State's share is up to \$18 million. Construction began in September 2011 with completion in June 2013.

Shasta County

This project will result in the replacement of the existing, antiquated 56-bed juvenile hall located in Redding with a new 90-bed juvenile detention facility and related ancillary space. Of the approximately \$18 million in project costs, the State's share is up to \$15,050,000. Construction began in April 2012 with completion scheduled for November 2013.

San Luis Obispo County

Award: \$13,120,983

This project will add 20 new detention beds, classrooms, treatment area and related ancillary space to the existing juvenile hall located in the city of San Luis Obispo. The County is targeting construction to begin in May 2014 with completion in March 2016.

Riverside County

Local juvenile facility

Award: \$24,698,105

Construct a new 100-bed treatment (camp) facility and related ancillary space in Riverside replacing an outdated facility. This project was established in September 2013.

REMAINING PROJECTS WITH A CONDITIONAL AWARD

The projects outlined below are not yet established in the State Public Works Board approval and oversight process for capital outlay projects.

Alameda County

Local juvenile facility

Award: \$35,000,000

Replace the existing aged and dilapidated camp in San Leandro with a new 150-bed camp and related ancillary space, providing residential treatment and rehabilitation for male and female youth.

Colusa County

Local juvenile facility

Award: \$5,655,740

Construct a new 10-bed juvenile rehabilitation facility and related ancillary space in Colusa.

Humboldt County

Local juvenile facility

Award: \$12,930,869

Construct a new 30-bed juvenile hall replacement facility and related ancillary space in Eureka.

Los Angeles County

Local juvenile facility

Award: \$28,728,123

Demolish and reconstruct a camp facility in Malibu to include 120 beds and related ancillary space.

Merced County

Local juvenile facility

Award: \$8,897,708 Declined

Construct a new 60-bed camp facility and related ancillary space in El Nido. The county has declined the award.

Monterey County

Local juvenile facility

Award: \$35,000,000

Construct a new 150-bed juvenile hall and related ancillary space in Salinas replacing the existing 50 year old facility.

Santa Clara County

Local juvenile facility

Award: \$12,950,000

Add nine 12-bed therapeutic units (84 beds total) and related ancillary space to the existing Boys Ranch located in Morgan Hill. The project also includes constructing additional classrooms and converting an existing dormitory into recreation and visiting space. The project is anticipated to be established in December 2013.

Santa Cruz County

Local juvenile facility

Award: \$1,355,608

Construct an indoor multi-use recreation and programs facility at the existing juvenile hall site in Felton to serve both in-custody youth at the existing juvenile hall and probationers under community supervision. The project is anticipated to be established in October 2013.

Tuolumne County

Local juvenile facility

Award: \$16,000,000

As the host county, construct a new 30-bed regional juvenile hall and ancillary space in Sonora for Tuolumne's youths and the youth in the neighboring counties of Calaveras, Amador, Mariposa and Mono.

Yolo County

Local juvenile facility

Award: \$4,784,536

Construct an indoor multipurpose recreation, programs and visitor center on the grounds of the existing juvenile hall located in Woodland to serve the youth in-custody and youth under community supervision after their release.
